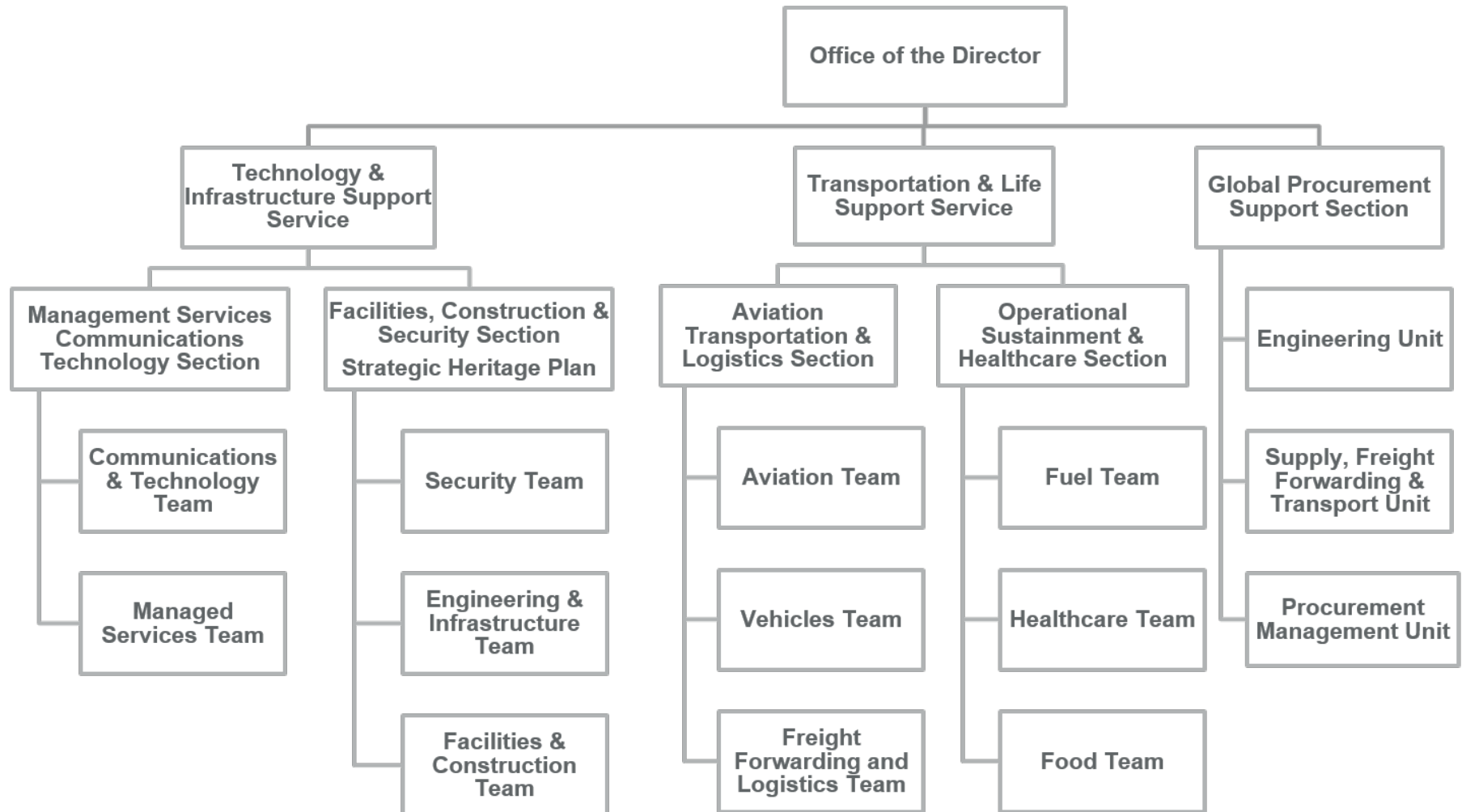

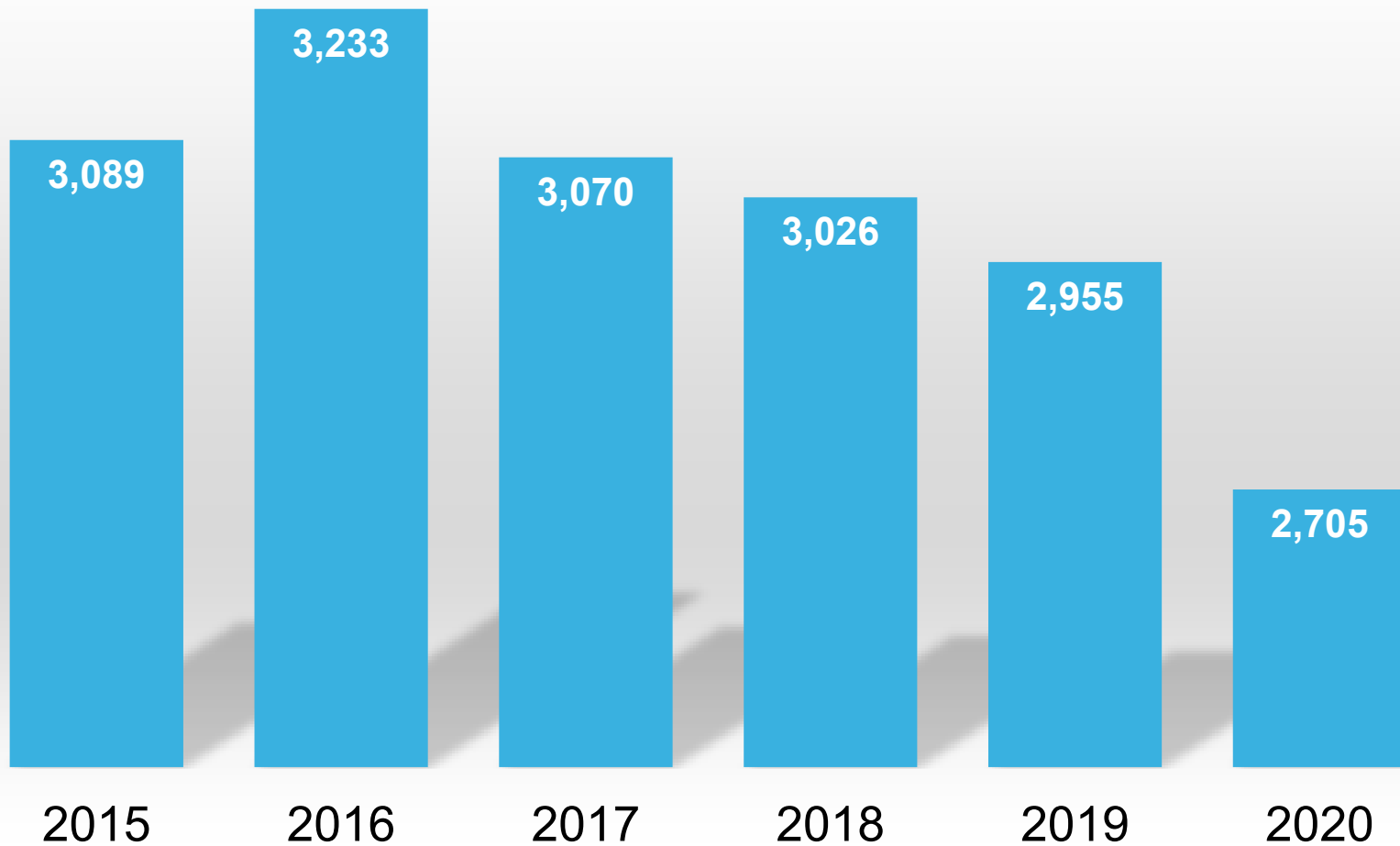
Procurement Division Organizational Chart

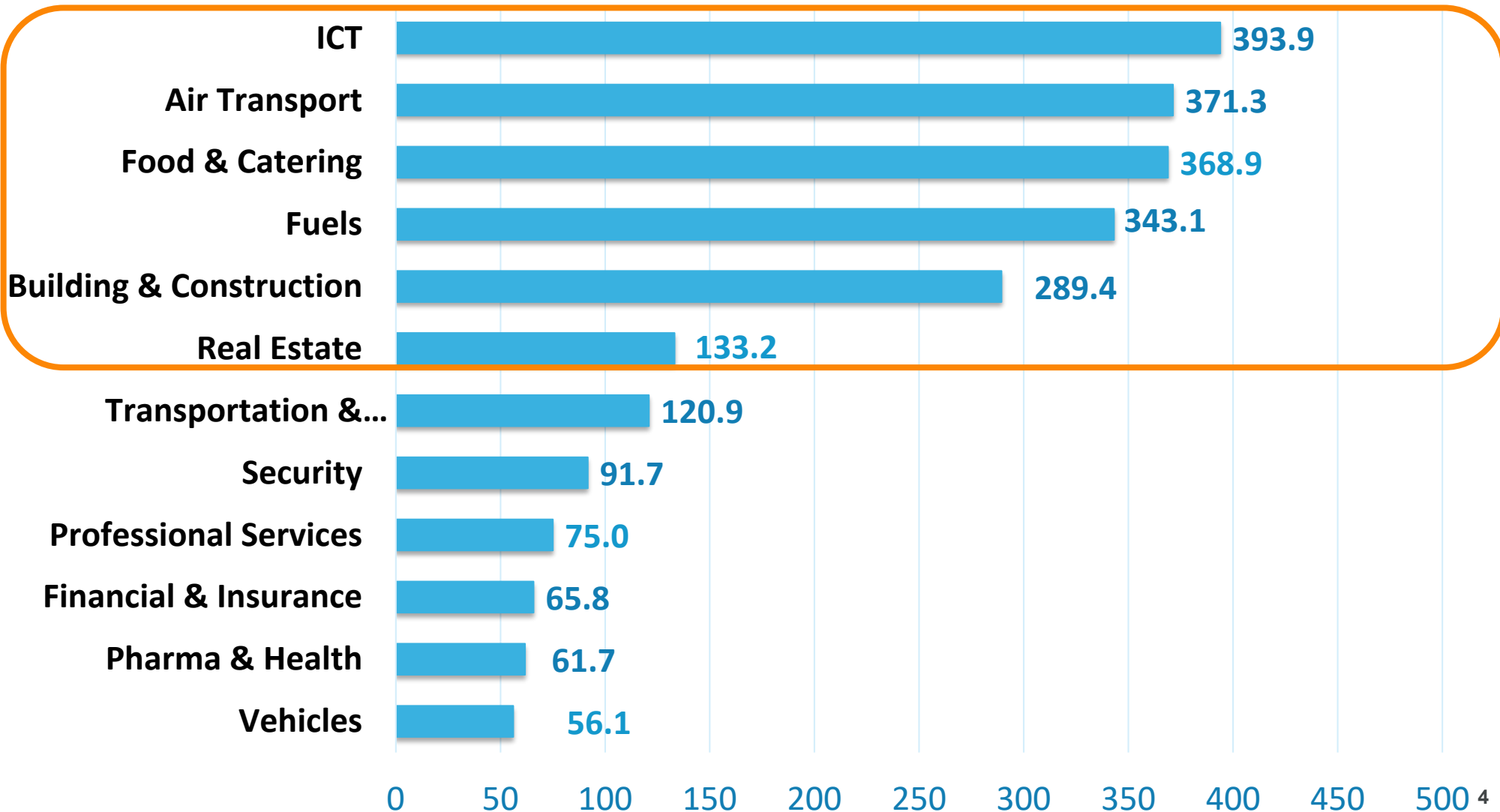
UN Secretariat Procurement Volume (2015 – 2020)

US\$ in Millions

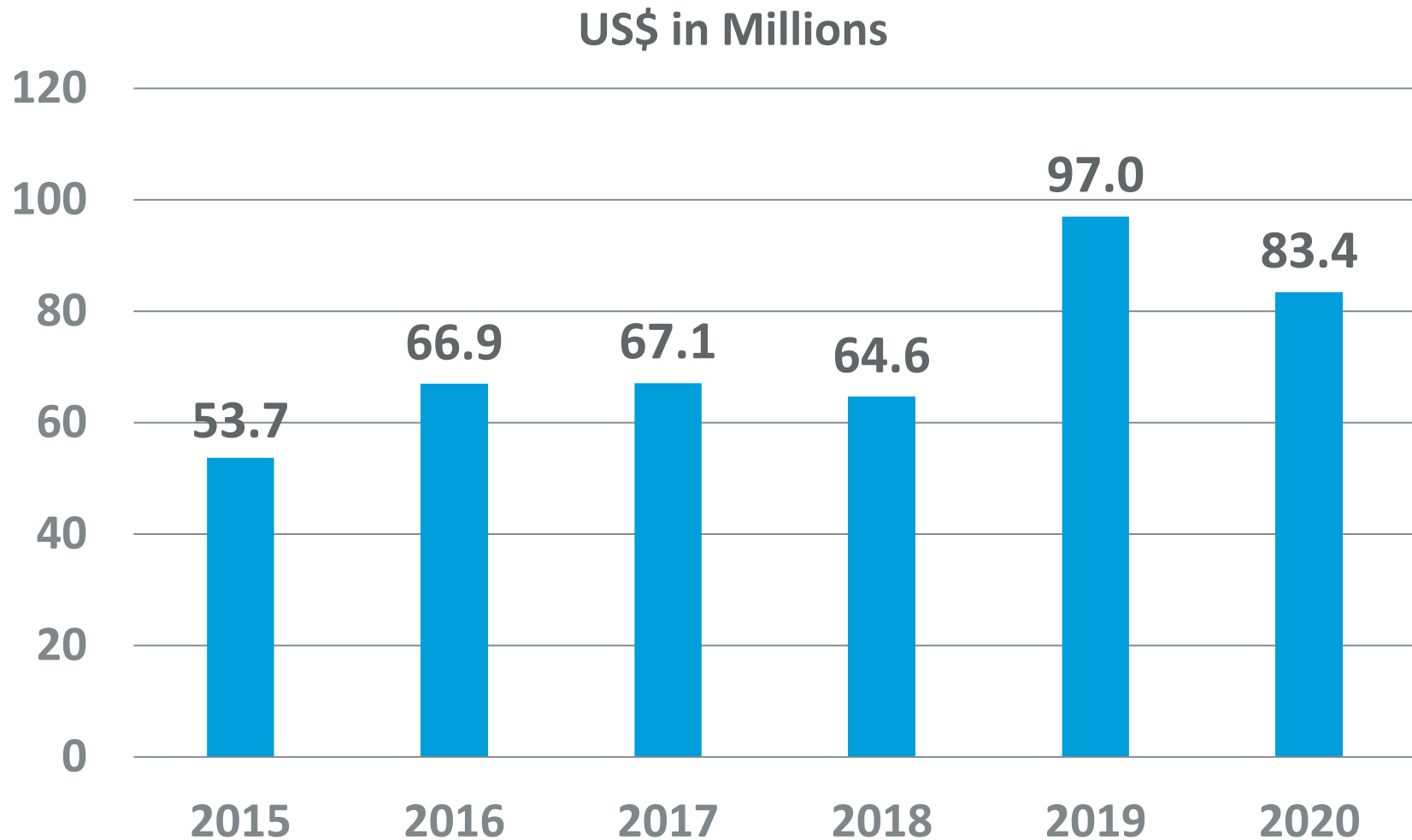


UN Secretariat Procurement by Major Commodity (2020)

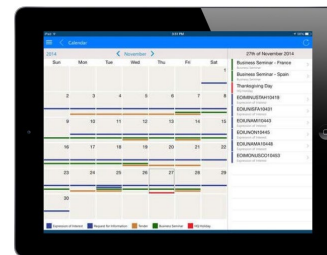

Some features are only available for iOS. An update to the Android version is coming soon.



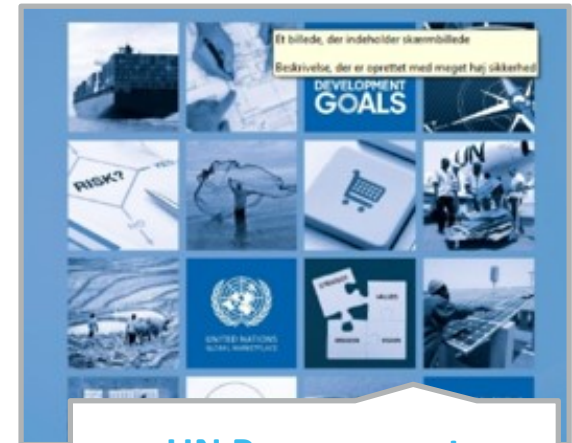

What kind of food are included in food rations?

UN purchases 524 different food items grouped into:

- Category 1000 - Meats, Fish, Nuts, Beans & Dairy
- Category 2000 - Breads, Grains, Cereals & Beverages
- Category 3000 - Fats, Oils & Sweets
- Category 4000 - Fruit, Vegetables & Spices
- Category 6000 & 9000 - Halal Food

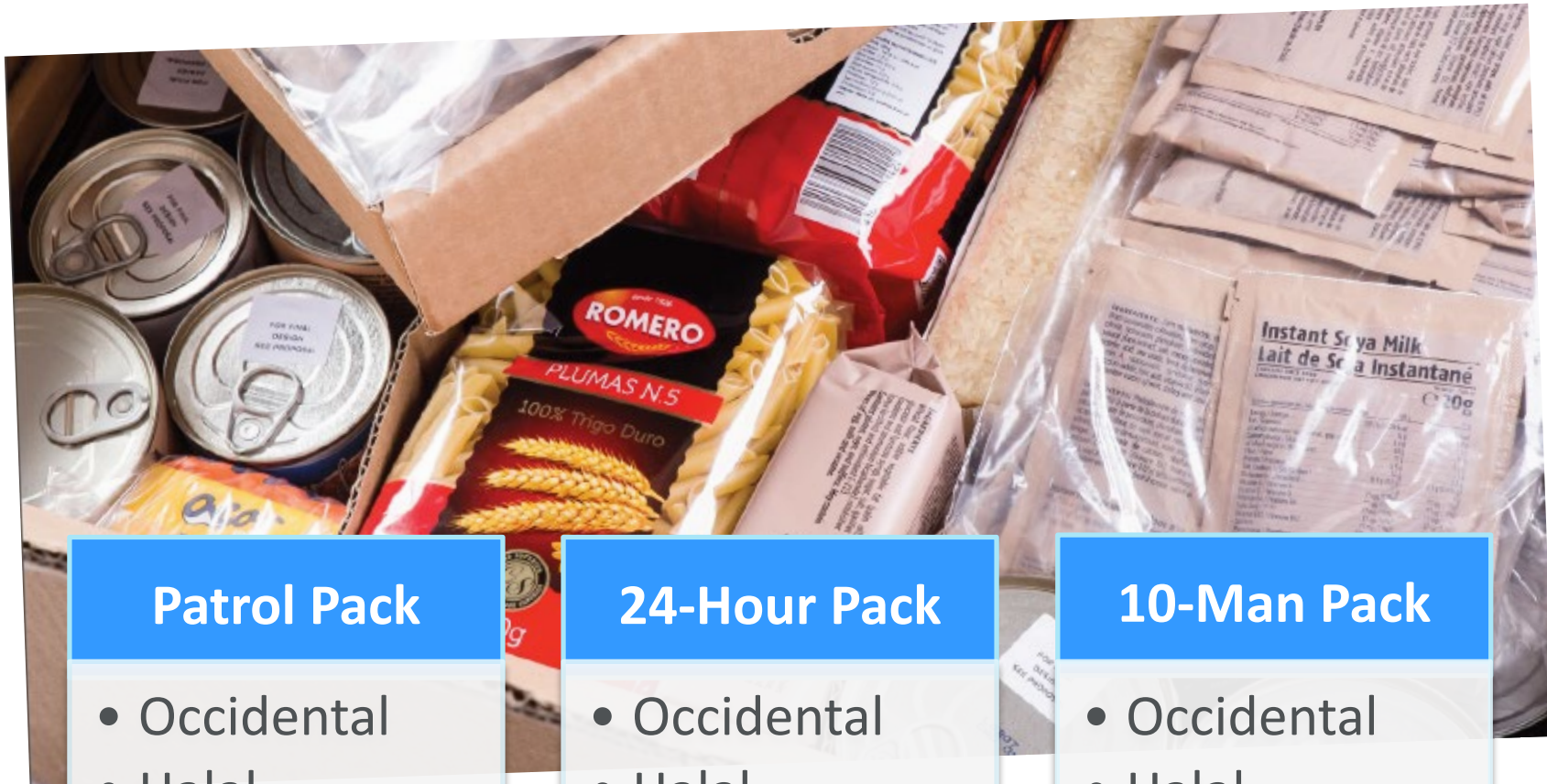
- Food specifications (nutritional value, etc.)
- Contaminants (maximum residue limit, etc.)
- Product Labeling (labeling requirement)
- Certification (quality management and sub-supplier classification, etc.)
- Inspection (risk and inspection classification)
